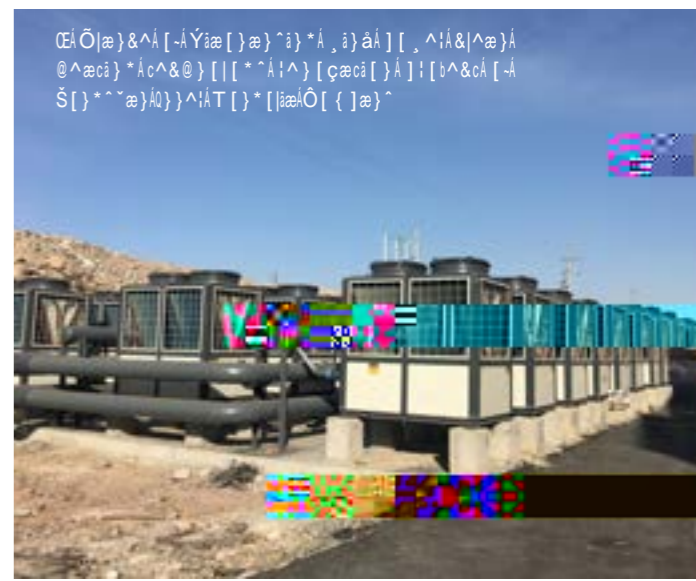
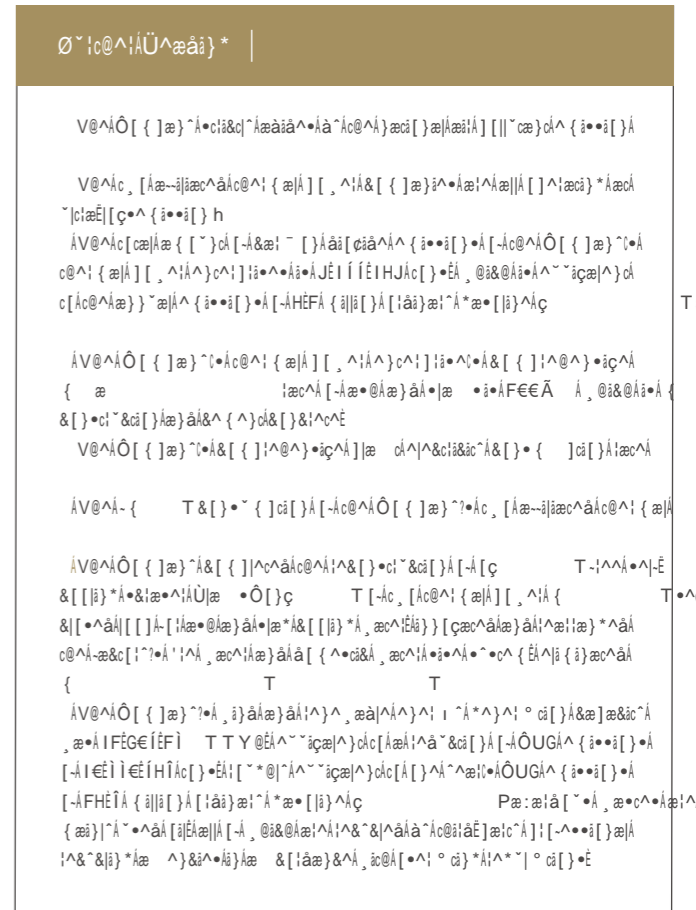
Energy Conservation and Emission Reduction

In December 2019, Longyuan Inner Mongolia Company's new energy wind power clean heating technology renovation project was launched to provide heat to a stone processing park in Ulanqab with a heating area of approximately 100,000 square meters, marking the success of Xiaonanying's wind power heating technology renovation project start up and its entering to the trial operation phase.
